2. Play starts on Friday, September 15, 2017 at 3:00pm. All players must be available to play at this time if the draw requires.
3. Participation is limited to 1 event per person.
4. The tournament director reserves the right to eliminate a division if there are insufficient entries and will contact you regarding your option to play in another division.
5. All matches will be the best of 3 sets. Games will be regular scoring. The 12 point tie-break will be used at 6 games all. Third set 10 point tiebreaker. Semi and Final Round matches will be regular scoring. Rules may change due to size of draw.
6. Players should report to the tournament desk 15 minutes prior to their match.
7. A 15-minute default time will be strictly enforced.
8. Players are responsible for their own starting times. Please call (808) 882-5420 beginning Thursday, September 14, 2016.
